SUMMARY

Construction of a permanent turnout structure known as CLWA-01 consists of a new concrete valve vault equipped with a 36-inch conical plug valve, a new meter vault equipped with a 36-inch magnetic type flow meter, approximately 200 feet of 48-inch associated piping, electrical and supervisory control and data acquisition (SCADA) telemetry equipment. This facility will replace the current temporary connection which would serve as a back-up when the permanent turnout is taken off line for maintenance. The current connection has a maximum capacity of 60 MGD. The new connection will allow the Rio Vista Water Treatment Plant (RVWTP) to receive deliveries at its current permitted operating capacity of 66 MGD and any capacity expansions up to 90 MGD. (FY 2016/17 Action A5.1: Initiate construction of the permanent raw water connection to Metropolitan Water District Foothill Feeder pipeline.)

DISCUSSION

On January 31, 2017, twelve bids were received and opened for the Foothill Feeder Turnout No. CLWA 01 Project. A summary of the bids is presented below:

The apparent low bid is from GSE Construction Co., Inc. (GSE), for a total of \$2,691,300. The engineer's estimate for the project is \$3,315,000. Staff and the design consultant, Kennedy/Jenks Consultants (K/J), have reviewed GSE's proposal and concluded that the bid is complete. Staff has verified that GSE is a properly licensed contractor in the State of California. Staff has been satisfied with other Agency construction projects performed by GSE.

Staff requested the engineering design consultant, K/J, provide a proposal for professional engineering services during construction. K/J's services include attending various construction meetings, performing construction observation site visits, responding to contractor's requests for information and clarifications, reviewing contractor submittals for conformance to the project's technical requirements, reviewing request for quotes, assisting in the stormwater pollution prevention plan implementation, assisting during project start-up and preparing as-built drawings.

Staff also requested Vali Cooper & Associates, Inc. (Vali Cooper), to provide a proposal for construction management and inspection services to include managing and coordinating construction meetings and documentation, monitoring construction activities, performing inspections, reviewing progress pay estimates and construction performance, and coordinating project start-up and training activities.

CEQA Determination

The environmental effects from the design, construction, and operation of the Foothill Feeder connection were originally evaluated in the RVWTP Expansion Project Final Environmental Impact Report, which was certified by the CLWA Board of Directors on August 23, 2006 (CLWA Resolution No. 2480). The Board also approved the Findings of Fact, the Mitigation Monitoring and Reporting Program, and a Statement of Overriding Considerations for the project. There are no substantial changes to the original project. The previous environmental documentation certified by the Board in conjunction with the proposed action fully complies with CEQA and the State CEQA Guidelines and no further environmental analysis or documentation is required for the Board to act on the proposed action.

FINANCIAL CONSIDERATIONS

GSE's total construction bid is \$2,691,300. K/J's budget for professional engineering services during construction is \$265,000. Vali Cooper's budget for construction management and inspection services is \$450,000. Both K/J and Vali Cooper's work would be performed on a time and expense basis. The project is funded in the Agency's FY 2016/17 Budget and there are adequate funds remaining for this work. The total project budget is \$5,308,000 and the FY 2016/17 project budget amount is \$4,859,000. As of December 31, 2016, project expenditures are \$1,274,341. The project was awarded a \$1,500,000 Proposition 84 Round 2 Implementation Grant from the State Department of Water Resources.

RECOMMENDATIONS

That the Planning and Engineering Committee recommends that the Board of Directors (1) approve the attached resolution awarding a construction contract to GSE Construction Co., Inc., for construction of the Foothill Feeder Turnout No. CLWA 01 Project for \$2,691,300, (2) authorize the General Manager to execute a work authorization to Kennedy/Jenks Consultants for engineering services during construction for an amount not to exceed \$265,000 and (3) authorize the General Manager to execute a work authorization to Vali Cooper & Associates for construction management services for an amount not to exceed for \$450,000.

WHEREAS, the environmental effects from the design, construction, and operation of the Foothill Feeder connection were originally evaluated in the Rio Vista Water Treatment Plant Expansion Project Final Environmental Impact Report, which was certified by the Board on August 23, 2006 (CLWA Resolution No. 2480). SUMMARY

The Earl Schmidt Filtration Plant (ESFP) Clearwell/CT Improvements Project has been advertised for construction bids. Bids have been received and staff is recommending award of a construction contract. (FY 2016/17 Action A5.3: Initiate construction of the Earl Schmidt Filtration Plant Clearwell/CT Improvements Project.)

DISCUSSION

The Agency is planning to improve the disinfection process at the ESFP. The improvements will include a new disinfection contact basin which will increase the baffling factor from the existing 0.10 to 0.70 or greater. A higher disinfection contact time will maintain regulatory compliance and provide operational flexibility at the ESFP.

On January 25, 2017, thirteen bids were received and opened for construction of the Earl Schmidt Filtration Plant Clearwell/CT Improvements Project. Two bidders subsequently requested to withdraw their bids due to clerical errors. A summary of the bids is presented below:

The apparent responsive low bid is from Clark Bros. Inc. (Clark) for a total of \$5,623,745. The engineer's estimate for the project is \$5,641,000. Staff has reviewed Clark's proposal and concluded the bid is complete and the information provided in the bid package is comprehensive and accurate. The bid package did not contain any irregularities or omissions. Staff has verified that Clark is a properly licensed contractor in the State of California and is registered with the Department of Industrial Relations. Staff has contacted a number of Clark's references and has been told its work performance to be satisfactory in all respects.

Staff has also requested the engineering design consultant, Michael Baker International (Baker), provide a proposal for professional engineering services during construction. Baker's services include attending various construction meetings, responding to contractor's requests for information, reviewing contractor submittals for conformance to the project's technical aspects and updating the construction drawings to reflect changes made during construction.

Staff also requested RMC Water and Environment (RMC) provide a proposal for construction management and inspection services to include managing and coordinating construction meetings and documentation, monitoring construction activities, performing inspections, reviewing progress pay estimates and construction performance and coordinating project start-up activities.

CEQA Determination

The proposed action was previously determined to be categorically exempt under the provisions of CEQA and the State CEQA Guidelines. The project was found to be exempt under Class 1, Section 15301 of the State CEQA Guidelines. A Notice of Exemption (NOE) was filed with the Los Angeles County Clerk in July 2013 and the statute of limitations has ended. With the current Board action, there is no substantial change proposed to the project since the original NOE was filed. Hence, the previous environmental documentation in conjunction with the project fully complies with CEQA and the State CEQA Guidelines. The CEQA determination is that the proposed action has been previously addressed in the 2013 NOE (Class 1, Section 15301 of the State CEQA Guidelines) and that no further environmental analysis or documentation is required.

FINANCIAL CONSIDERATIONS

Clark's total construction bid is \$5,623,745. Baker's budget for professional engineering services during construction is \$177,000. RMC's budget for construction management services is \$734,000. Both Baker and RMC's services would be performed on a time and expense basis. The project is funded in the Agency's FY 2016/17 Budget and there are adequate funds remaining for this work. The total project budget is \$9,047,000 and the FY 2016/17 project budget amount is \$4,056,000. As of December 31, 2016, project expenditures are \$1,082,000.

RECOMMENDATIONS

That the Planning and Engineering Committee recommends that the Board of Directors accept the withdrawal of two of the submitted construction bids and (1) approve the attached resolution awarding a construction contract to Clark Bros. Inc., for construction of the Earl Schmidt Filtration Plant Clearwell/CT Improvements Project in the amount of \$5,623,745, (2) authorize the General Manager to execute a work authorization to Michael Baker International for professional engineering services during construction for an amount not to exceed \$177,000, and (3) authorize the General Manager to execute a work authorization to RMC Water and Environment for construction management services for an amount not to exceed \$734,000.
