FELONY COMPLAINT

The undersigned is informed and believes that:

#### COUNT 1

On or between November 8, 2012 and March 28, 2013, in the County of Los Angeles, the crime of EMBEZZLEMENT OF PUBLIC FUNDS, in violation of PENAL CODE SECTIONS 504 and 514, a Felony, was committed by DAVID RUBIRA, who, while serving as an officer of a city, or a deputy, clerk, or servant of that officer, specifically, as an Assistant Engineer for the City of Santa Clarita, fraudulently appropriated to a use or purpose not in the due and lawful execution of his trust, public funds in his possession and/or under his control by virtue of that trust, and /or secreted it with a fraudulent intent to appropriate it, to wit, \$13,140 in funds made payable to Design Control.

## COUNT 2

On or about November 8, 2012, in the County of Los Angeles, the crime of EMBEZZLEMENT OF PUBLIC FUNDS, in violation of PENAL CODE SECTIONS 504 and 514, a Felony, was committed by DAVID RUBIRA, who, while serving as an officer of a city, or a deputy, clerk, or servant of that officer, specifically, as an Assistant Engineer for the City of Santa Clarita, fraudulently appropriated to a use or purpose not in the due and lawful execution of his trust, public funds in his possession and/or under his control by virtue of that trust, and /or secreted it with a fraudulent intent to appropriate it, to wit, \$3,000 in funds made payable to Raymond Scurria.

#### COUNT 3

On or between December 20, 2012 and March 28, 2013, in the County of Los Angeles, the crime of EMBEZZLEMENT OF PUBLIC FUNDS, in violation of PENAL CODE SECTIONS 504 and 514, a Felony, was committed by DAVID RUBIRA, who, while serving as an officer of a city, or a deputy, clerk, or servant of that officer, specifically, as an Assistant Engineer for the City of Santa Clarita, fraudulently appropriated to a use or purpose not in the due and lawful execution of his trust, public funds in his possession and/or under his control by virtue of that trust, and /or secreted it with a fraudulent intent to appropriate it, to wit, \$31,791.69 in funds made payable to Diamond Developers and Design.

#### **COUNT 4**

On or between June 6, 2013 and October 9, 2014, in the County of Los Angeles, the crime of EMBEZZLEMENT OF PUBLIC FUNDS, in violation of PENAL CODE SECTIONS 504 and 514, a Felony, was committed by DAVID RUBIRA, who, while serving as an officer of a city, or a deputy, clerk, or servant of that officer, specifically, as an Assistant Engineer for the City of Santa Clarita, fraudulently appropriated to a use or purpose not in the due and lawful execution of his trust, public funds in his possession and/or under his control by virtue of that trust, and /or secreted it with a fraudulent intent to appropriate it, to wit, \$226,991.50 in funds made payable to Sikand Engineering and Survey.

### COUNT 5

On or between June 6, 2013 and January 2, 2015, in the County of Los Angeles, the crime of EMBEZZLEMENT OF PUBLIC FUNDS, in violation of PENAL CODE SECTIONS 504 and 514, a Felony, was committed by DAVID RUBIRA, who, while serving as an officer of a city, or a deputy, clerk, or servant of that officer, specifically, as an Assistant Engineer for the City of Santa Clarita, fraudulently appropriated to a use or purpose not in the due and lawful execution of his trust, public funds in his possession and/or under his control by virtue of that trust, and /or secreted it with a fraudulent intent to appropriate it, to wit, \$150,908 in funds made payable to KPA Valencia.

### COUNT 6

On or about February 12, 2015, in the County of Los Angeles, the crime of EMBEZZLEMENT OF PUBLIC FUNDS, in violation of PENAL CODE SECTIONS 504 and 514, a Felony, was committed by DAVID RUBIRA, who, while serving as an officer of a city, or a deputy, clerk, or servant of that officer, specifically, as an Assistant Engineer for the City of Santa Clarita, fraudulently appropriated to a use or purpose not in the due and lawful execution of his trust, public funds in his possession and/or under his control by virtue of that trust, and /or secreted it with a fraudulent intent to appropriate it, to wit, \$7,800 in funds made payable to Santa Clarita Valley Facilities.

## COUNT 7

On or between April 9, 2015 and April 14, 2015, in the County of Los Angeles, the crime of EMBEZZLEMENT OF PUBLIC FUNDS, in violation of PENAL CODE SECTIONS 504 and 514, a Felony, was committed by DAVID RUBIRA, who, while serving as an officer of a city, or a deputy, clerk, or servant of that officer, specifically, as an Assistant Engineer for the City of Santa Clarita, fraudulently appropriated to a use or purpose not in the due and lawful execution of his trust, public funds in his possession and/or under his control by virtue of that trust, and /or secreted it with a fraudulent intent to appropriate it, to wit, \$99,939 in funds made payable to Santa Clarita Valley Facilities.

# COUNT 8

On or between November 8, 2012 and April 14, 2015, in the County of Los Angeles, the crime of PUBLIC OFFICER EMBEZZLING FOR PERSONAL USE, in violation of PENAL CODE SECTION 424(A)(1), a Felony, was committed by DAVID RUBIRA, who being a person described in Penal Code Section 424 charged with the receipt, safekeeping, transfer, and distribution of public moneys, did in a manner not incidental and minimal without authority of law, appropriate the same, and a portion thereof, to personal use and the use of another.

It is further alleged, pursuant to Penal Code section 186.11(a), that the offenses set forth in counts 1-8 are related felonies, a material element of which is fraud and embezzlement, which involve a pattern of related felony conduct, and the pattern of related felony conduct involves the taking of more than Five Hundred Thousand Dollars (\$500,000).

It is further alleged as to count(s) 1, 2, 3, 4, 5, 6, 7 and 8 that in the commission of the above offense(s) the said defendant(s), DAVID RUBIRA, with the intent to do so, took, damaged, and destroyed property of a value exceeding \$200,000, within the meaning of Penal Code section 12022.6(a)(2).

It is further alleged as to count(s) 1, 2, 3, 4, 5, 6, 7 and 8 that the above offense is a theft of over \$100,000, within the meaning of Penal Code section 1203.045(a).

NOTICE: Conviction of this offense will require the defendant to provide DNA samples and print impressions pursuant to Penal Code sections 296 and 296.1. Willful refusal to provide the samples and impressions is a crime.

NOTICE: The People of the State of California intend to present evidence and seek jury findings regarding all applicable circumstances in aggravation, pursuant to Penal Code section 1170(b) and Cunningham v. California (2007) 549 U.S. 270.

NOTICE: A Suspected Child Abuse Report (SCAR) may have been generated within the meaning of Penal Code §§ 11166 and 11168 involving the charges alleged in this complaint. Dissemination of a SCAR is limited by Penal Code §§ 11167 and 11167.5 and a court order is required for full disclosure of the contents of a SCAR

NOTICE: Any allegation making a defendant ineligible to serve a state prison sentence in the county jail shall not be subject to dismissal pursuant to Penal Code § 1385.
