SUMMARY

The Earl Schmidt Intake Pump Station (ESIPS) Pipeline Improvements Project has been advertised for construction bids. Bids have been received and staff is recommending award of a construction contract. (FY 2017/18 Action B6.5: Initiate construction of the Earl Schmidt Intake Pump Station Pipeline Improvements Project.)

DISCUSSION

The ESIPS is located adjacent to Castaic Lake. Untreated water is conveyed from Castaic Lake through the ESIPS to the Earl Schmidt Filtration Plant (ESFP). When the lake level is high, the water is bypassed around the pumps at the ESIPS; however, when the lake level is low, the ESIPS pumps are used to pump water to the ESFP. In February 2016, when Pump No. 2 was started, it was discovered that the suction pipeline was leaking. During the repair work, a portion of the pipeline was found to have settled. The Agency's design consultant, Lee & Ro, Inc. (Lee & Ro), determined the main deficiency to be settlement of a portion of the buried suction pipeline header and improvements were identified to correct the deficiency. The proposed pipeline improvements include the excavation and removal of the impacted pipelines and appurtenances and the re-installation of those pipelines and appurtenances inside a new concrete structure.

The project has been advertised in the local newspaper on three different dates and on the Agency's website for construction bids. On June 27, 2017, four bids were received and opened for construction of the ESIPS Pipeline Improvements Project. A summary of the bids is presented below:

The apparent responsive low bid is from Pacific Hydrotech Corp. (PHC) for a total of \$3,083,100. The engineer's estimate for the project is \$3,076,100.

During the review of PHC's proposal, staff identified a minor irregularity in that PHC did not submit the Certificate for Workers' Compensation Insurance form with their bid. CLWA's General Counsel has advised that this missing form did not give PHC an advantage over the other bidders and that the form can legally be provided after bid opening and prior to the performance of any work of the contract. PHC provided the completed form after the bid opening. CLWA's General Counsel also advised that this irregularity can be waived as an immaterial deviation under Section IB-16 of the Instructions to Bidders and California law. PHC is a properly licensed contractor in the State of California and is registered with the Department of Industrial Relations. Staff has contacted PHC's references and the references provided positive comments.

Staff has requested the engineering design consultant, Lee & Ro, to provide a proposal for professional engineering services during construction. Lee & Ro's services include attending various construction meetings, responding to contractor's requests for information, reviewing contractor submittals for conformance to the project's technical aspects and updating the construction drawings to reflect changes made during construction.

Staff has also requested Michael Baker International (MBI) to provide a proposal for construction management and inspection services to include managing and coordinating construction meetings and documentation, monitoring construction activities, performing inspections, reviewing progress pay estimates and construction performance and coordinating project start-up activities.

CEQA Determination

The proposed action was previously determined to be categorically exempt under the provisions of CEQA under Class 1, Section 15301 of the State CEQA Guidelines. A Notice of Exemption was filed with the Los Angeles County Clerk on October 6, 2016 and the statute of limitations has ended. With the current Board action, there are no substantial changes proposed to the project since the original NOE was filed. Hence, the previous environmental documentation in conjunction with the project fully complies with CEQA and the State CEQA Guidelines and no further environmental analysis or documentation is required.

FINANCIAL CONSIDERATIONS

PHC's total construction bid is \$3,083,100. Lee & Ro's budget for professional engineering services during construction is \$195,000. MBI's budget for construction management services is \$467,000. Both MBI and Lee & Ro's services would be performed on a time and expense basis. The project is funded in the Agency's FY 2017/18 Budget. The project's total estimated cost is \$4,083,000. The FY 2017/18 project budget amount is \$3,706,000. As of May 31, 2017, project expenditures are \$387,149.

RECOMMENDATIONS

That the Planning and Engineering Committee recommends that the Board of Directors (1) approve the attached resolution awarding a construction contract to Pacific Hydrotech Corp., for construction of the ESIPS Pipeline Improvements Project in the amount of \$3,083,100, (2) authorize the General Manager to execute a work authorization to Lee & Ro, Inc. for professional engineering services during construction for an amount not to exceed \$195,000, and (3) authorize the General Manager to execute a work authorization with Michael Baker International for construction management services for an amount not to exceed \$467,000.

RESOLUTION OF THE BOARD OF DIRECTORS OF THE CASTAIC LAKE WATER AGENCY AWARDING A CONSTRUCTION CONTRACT TO PACIFIC HYDROTECH CORP. FOR THE ESIPS PIPELINE IMPROVEMENTS PROJECT

WHEREAS, all bid proposals submitted to the Castaic Lake Water Agency (Agency) pursuant to the Agency's specifications (Project No. 200151) for the construction of the ESIPS Pipeline Improvements Project, as amended by Addenda, were publicly opened and read at the Agency's offices on Tuesday, June 27, 2017 at 2:00 p.m., in full accordance with the law and the Agency's customary procedures; and

WHEREAS, the Board of Directors finds, after considering the opinion of staff, that the total bid of Pacific Hydrotech Corp. in the amount of \$3,083,100 is the lowest bid of four bids submitted, and that said bid substantially meets the requirements of said specifications as amended by Addenda; and

WHEREAS, the irregularity in the omission of the Certificate for Workers' Compensation Insurance form is waivable under Section IB-16 of the Instructions to Bidders and California law: and

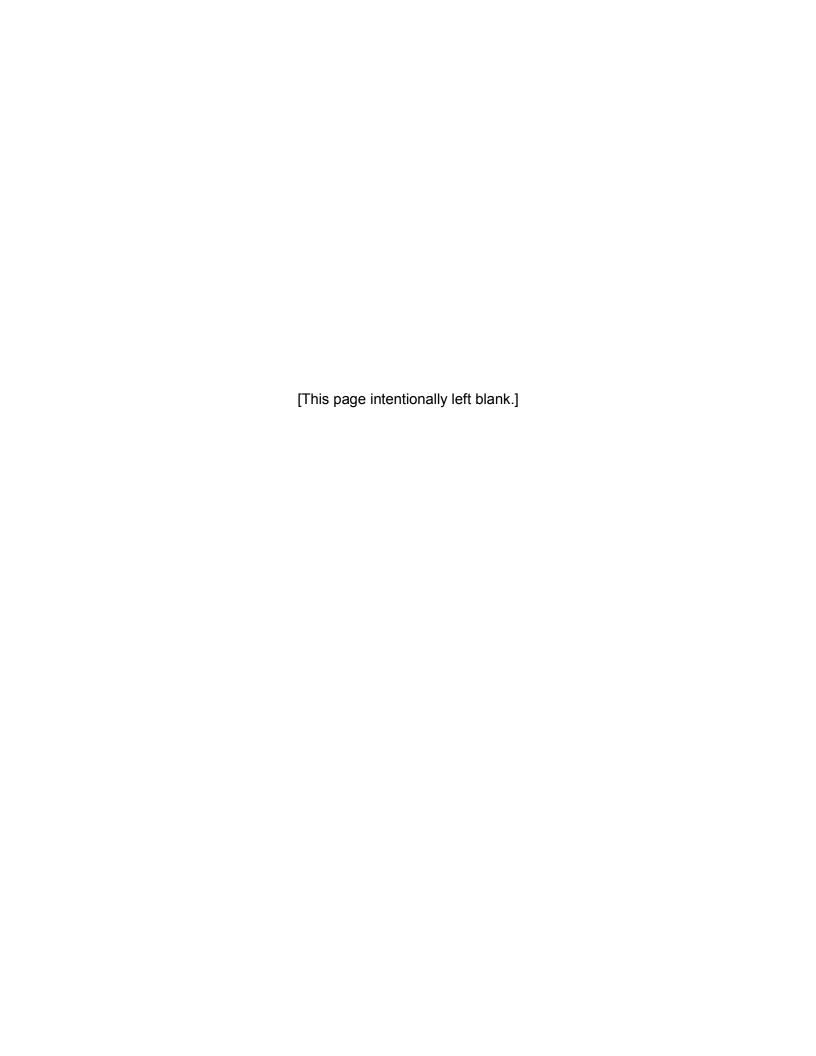
WHEREAS, it is in the Agency's best interest that the Board of Directors, on behalf of the Agency, authorize its General Manager to accept the \$3,083,100 bid; and

WHEREAS, the project was previously determined by the Board to be categorically exempt under provisions of CEQA and the State CEQA Guidelines on October 6, 2016, and there are no substantial changes to the project, and no further CEQA documentation is necessary for the Board to act with regards to the proposed actions.

NOW, THEREFORE, BE IT RESOLVED that the Agency's Board of Directors does authorize its General Manager to accept said low bid and does thereafter authorize the Agency's General Manager or its Engineering and Operations Manager to issue a Notice of Award to Pacific Hydrotech Corp., hereby found to be the "lowest responsible bidder" for the ESIPS Pipeline Improvements Project for the total sum of \$3,083,100 pursuant to said Agency specifications as amended by Addenda.

RESOLVED FURTHER that the Agency's General Manager or its President and Secretary are thereupon authorized, upon receipt of appropriate payment and performance bonds, appropriate certificates of insurance and an executed Contract Agreement from Pacific Hydrotech Corp., all of which must be approved by General Counsel, to execute the said Contract Agreement on behalf of the Agency.

RESOLVED FURTHER that the Agency's General Manager or its Engineering and Operations Manager are thereafter authorized to execute and forward to Pacific Hydrotech Corp. an appropriate Notice to Proceed.
