Status of Sustainable Groundwater Management Act Implementation

SUMMARY AND DISCUSSION

On June 15, 2017, Department of Water Resources (DWR) reviewed, approved and posted the Santa Clarita Valley Groundwater Sustainability Agency (SCV-GSA) formation notice on its website, starting the 90-day public review period. This period expires September 13, 2017. Staff anticipates that that DWR will name the SCV-GSA as the exclusive GSA for this area.

With the selection of the two County of Los Angeles board members, SCV-GSA Board member selection is complete. Board members are shown in the table below:

In preparation for the initial SCV-GSA meeting in late September, the GSA formation work group is developing a series of background briefing reports including:


- Sustainable Groundwater Management Act (SGMA): overview of purpose, responsibilities, and authorities
- Groundwater Sustainability Plans (GSPs): creation of groundwater sustainability plan
- Governance: Memorandum of Understanding and Joint Powers Agency

The GSA formation group will also recommend that SCV-GSA adopt a resolution authorizing submittal of a Proposition 1 grant to support preparation of a GSP for the Santa Clarita Valley. Staff anticipates that DWR will issue a Proposal Solicitation Package (PSP) for GSPs in late August 2017 or early September 2017 with completed applications being due within 9 weeks. Accordingly, Agency staff, along with other water purveyor staff, has initiated work on an application. Staff will prepare a draft grant application along with a draft agreement providing CLWA with reimbursements for costs associated with preparing the grant.

A work group meeting is scheduled for September 6, 2017 and staff will provide an update on these items during the September 6, 2017 Water Resources Committee meeting.

SUMMARY AND DISCUSSION


Rosedale-Rio Bravo (RRB) awarded a well equipping contract for the five Superior Wellfield wells. Work includes supplying and installing electrical controls, pumps, motors, piping and site work. Start up, testing, and final completion are scheduled for January 2018.

Well development of the sixth well (Matuk well) is scheduled for completion in August 2017. Step drawdown tests, followed by a constant rate discharge test, are scheduled for completion in September 2017. Groundwater samples will be collected during the drawdown tests. Following well development, pump test data will be analyzed to support well equipping design. Well equipping is anticipated to take place in Spring 2018.

Construction of the Superior Wellfield Pipeline continues to be on hold until recharge operations are completed in the adjacent recharge pond and the pond can be dewatered. Construction of the pumping plant is continuing with floor and wall construction. Construction of the cofferdam in the Cross Valley Canal has been completed.

RRB is preparing a revised project schedule to reflect completed work and to refine the project completion date. We currently anticipate the Agency's financial commitment to completion of infrastructure work will be completed in Spring 2018. Completion of remaining infrastructure (funded by RRB), such as the pumping plant, will be completed by August 2018.
